David Cooper claims that 'Existentialism is not a mood or a vocabulary, but a relatively systematic philosophy'. Dostoyevsky explicit his character through complex in nature. His themes are psychological and ethical. *All Men are Mortal* is written by Simon de Beauvoir. In his work he says about the relation and time. The character Fosca is immortal and it dedicates to the world.
